When unethical behavior occurs (including ex post discovery of unethical behavior related to past transactions with you), information about the occurrence of unethical behavior by you/our company and the specific details of the unethical behavior (hereinafter "information on unethical behavior") to you and all affiliates within the corporate group (SK) to which you belong (hereinafter referred to as "affiliates for sharing information on unethical behavior") agree to be notified. The company / I confirm that this notification and the resulting sharing of information on unethical behavior does not constitute a breach of your confidentiality obligations nor constitute an infringement of our/our trade secrets.
- 4. The company / I agree that this company and affiliates for sharing information on unethical behavior, for our unethical behavior(including our publicly known unethical behavior that occurred in connection with other companies and transactions with third parties), can subject the company to sanctions (which can include denial of contract renewal, restriction on new contracts; but in the case of the company that is a direct party to the transaction in which the unethical act occurs, the sanction is not limited to this and reasonable sanctions corresponding to the unethical conduct can apply) in business transactions (including, but not limited to, participation in future bids). We confirm that we will not file any complaints against this company or the other unethical behavior notification recipient companies that accuses civil or criminal liability.
